I UNDERSTAND THAT:

- The activities are physically and mentally intense and may require extreme exertion to play.
- The activities can be dangerous if not played in accordance with the stated rules, which are explained to me before play is commenced.
- Should I be unsure of any of the game's rules I shall seek clarification before playing.
- The nature of the activity means that there is the possibility of injury to myself or others.

I CONFIRM AND AGREE THAT:

- I am fully aware of the risks to myself and others involved in the activities of Elsham Activity Centre Limited and that I will never under any circumstances purposely shoot anybody in the head or face.
- I am physically fit and mentally able to undertake the arduous activities as undertaken with Elsham Activity Centre Limited.
- I will comply with all rules of Elsham Activity Centre Limited and use only equipment and methods as instructed so not to injure or hurt myself and others.
- I shall conform with all instructions of the owner, marshals or representatives of the owner however communicated.
- I understand the need to wear certain items for my own protection (i.e. goggles) and that I shall not under any circumstances remove them when in the play area. That any injury received while not wearing the correct items could be deemed as contributory negligence on my part.

RELEASE:

I hereby release, remise and forever discharge from any claims and liability what so ever and without limitation that I might have against Elsham Activity Centre Limited, associated businesses, the owner and the owner's representatives and any other player in the game who might injure me during the normal course of the activities undertaken.

RENT AND AGREEMENT:

I agree that I shall be liable for the sum of at least £100 payable to Elsham Activity Centre Limited in the event that the equipment as issued to myself is not returned at the end of the activities undertaken.

I have read and fully understand all the terms and conditions of this agreement and confirm that I am not relying on any statement or representations by any person or entity as an inducement to my fully and voluntarily engaging in the activities of Elsham Activity Centre Limited assuming the risks and obligations stated above and in signing this document.

I agree to pay in full all costs and charges incurred by myself while using the facilities of Elsham Activity Centre Limited. I further understand that should I fail to legally discharge any liability incurred by myself I shall be liable to administrative and legal costs, interest and bank charges. If I am the event organiser I agree to ensure that those players in my group fully understand that they will be required to settle their own accounts before leaving the site.
